ARTICLE II. JUDICIAL NOTICE RULE 201 .

Judicial Notice of Adjudicative Facts

(a) Scope. This rule governs judicial notice of an adjudicative fact only, not a legislative fact...

(c) Taking Notice. The court:

(2) must take judicial notice if a party requests it and the court is supplied with the necessary information.

(d) Timing. The court may take judicial notice at any stage of the proceeding.

(e) Opportunity to Be Heard. On timely request, a party is entitled to be heard on the propriety of taking judicial notice and the nature of the fact to be noticed. If the court takes judicial notice before notifying a party, the party, on request, is still entitled to be heard.

THE TEXAS CONSTITUTION *February 15, 1876*
ARTICLE 1. BILL OF RIGHTS

That the general, great and essential principles of liberty and free government may be recognized and established, we declare:

Sec. 2. INHERENT POLITICAL POWER; REPUBLICAN FORM OF GOVERNMENT. *All political power is inherent in the people, and all free governments are founded on their authority, and instituted for their (the People's) benefit.* The faith of the people of Texas stands pledged to the preservation of a republican form of government, and, subject to this limitation only, they have at all times the inalienable right to alter, reform or abolish their government in such manner as they may think expedient. **Second Point, MATERIAL OF FACTS:**

Sec. 9. SEARCHES AND SEIZURES. The people shall be secure in their persons, houses, papers and possessions, *from all unreasonable seizures* or searches, and *no warrant to search any place, or to seize any person or thing, shall issue without describing them as near as may be, nor without probable cause, supported by oath or affirmation.* **Third Point, MATERIAL OF FACTS:**

Sec. 10. RIGHTS OF ACCUSED IN CRIMINAL PROSECUTIONS. In all criminal prosecutions the accused shall have a *speedy public trial by an impartial jury.* He shall *have the right to demand the nature and cause of the accusation against him, and to have a copy thereof.* He shall not be compelled to give evidence against himself and *shall have the right of being heard by himself or counsel, or both,* shall be confronted by the witnesses against him **and shall have compulsory process for obtaining witnesses in his favor, except that when the witness resides out of the State and ...** **Further Point, MATERIAL OF FACTS:**

Sec. 15. RIGHT OF TRIAL BY JURY. *The right of trial by jury shall remain inviolate.* The Legislature shall pass such laws as may be needed to regulate the same, and to maintain its purity and efficiency. Provided, that the Legislature may provide for the temporary commitment, for observation and/or treatment, of mentally ill persons not charged with a criminal offense, for a period of time not to exceed ninety (90) days, by order of the County Court without the necessity of a trial by jury. **First Point, MATERIAL OF FACTS:**

Sec. 16. BILLS OF ATTAINDER; EX POST FACTO OR RETROACTIVE LAWS; IMPAIRING OBLIGATION OF CONTRACTS. *No bill of attainder, ex post facto law, retroactive law, or any law impairing the obligation of contracts, shall be made.* **Fourth Point, MATERIAL OF FACTS:**

MATERIAL OF FACTS

First Point: right to a trial by jury because the court moved against me without giving me a trial by jury, and I request to be heard preserving my right to face my Living accuser. **Sec. 15. THE TEXAS CONSTITUTION - 1876**
